



Agreement

1. We authorize Debbie Brazil (“Deb’s Purr-fect Pet Sitting”) to perform care and services as outlined in the attached Pet Care forms. We also authorize by our signatures below emergency veterinary care, releasing you from all liabilities related to transportation, treatment and expenses, except in the event of gross negligence or illegal conduct by Deb’s Purr-fect Pet Sitting. Should our specified veterinarian be unavailable, we authorize you to engage the services of the veterinarian of your choice. If we cannot be reached in a timely manner, we authorize you to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a licensed veterinarian. We agree to reimburse you for all expenses incurred, plus any additional fees for attending to this.
2. We agree to reimburse you for all fees incurred plus a 20% service fee for extra food and/or supplies that must be purchased.
3. In the event of inclement weather or natural disaster, you are entrusted to use your best judgment in caring for our pet(s) and home. We will hold you harmless for consequences relating to such decisions except in the event of gross negligence or illegal conduct by Deb’s Purr-fect Pet Sitting.
4. We will not hold you responsible for pet(s) care if we arrive home later than scheduled and we do not notify Deb’s Purr-fect Pet Sitting of the change in advance.
5. We will be responsible for any injury (i.e. pet bites, etc.) requiring medical attention to you due to our pet(s) or hazardous conditions of our premises.
Cat Clause: We understand that if our cat(s) stay outside, or if we request that your service let our cat(s) out, Deb’s Purr-fect Pet Sitting is not liable or responsible for our cat’s safety, and we assume the risk that our cat(s) may become lost or injured and require medical attention.
Dog Clause: We understand that Deb’s Purr-fect Pet Sitting may encounter aggressive or unleashed dogs while caring for our dog(s) outside our home or yard, and may not be able to prevent or stop every dogfight. We hold Deb’s Purr-fect Pet Sitting harmless from any injury to our dog(s) resulting from a dogfight. We understand that if we leave our dog(s) in our yard, gated area, or otherwise, we agree to assume risk that our dog(s) may escape from the area before you arrive, while you are opening the gate, or after you have left. Should our dog(s) escape, Deb’s Purr-fect Pet Sitting will make every reasonable effort to locate them and provide additional precautions that they deem necessary or reasonable to prevent a similar recurrence and we agree to reimburse you for time and expenses.
6. Deb’s Purr-fect Pet Sitting agrees to provide the services stated on the client information sheet in a reliable, caring and trustworthy manner. In consideration of these services, and as an express condition thereof, the client expressly waives and relinquishes any and all claims against said pet sitter and company including any act of burglary, property damage or illness of a pet that may occur except in the event of gross negligence or illegal conduct by Deb’s Purr-fect Pet Sitting.

7. We agree to take full responsibility for prompt payment of fees before services are rendered, unless other arrangements for payment have been made between my pet sitter and ourselves. A late charge of 25% will be added to unpaid balances after thirty (30) days. A fee of \$25.00 will be charged on all returned checks. A fee of 50% of the total invoice will be due immediately if cancellations are less than 72 hours before the first scheduled visit. If client returns early, there will be no refunds or credits given. Emergency situations will be considered. If cancellations occur during the holidays, there will be no credit or refund given. In the event it is necessary to initiate collection proceedings on the account, client will be responsible for attorney's fees and cost of collection.
8. We further authorize this contract to be valid approval for future service, permitting Deb's Purr-fect Pet Sitting to accept our telephone reservations for service. We will not assume a reservation until we have had a verbal and/or email confirmation from Deb's Purr-fect Pet Sitting.
9. We have reviewed the client information sheet and the above conditions and understand and agree to the contents of these forms.
